### Zoning Officer's Corner

Well, it is that time of year again. Even with the cool weather we have been experiencing the grass has started to grow. Jackson Township does have a "Property Maintenance" ordinance that specifically addresses height of grass and weeds.

#### **Chapter 93. Property Maintenance states the following:**

**93-1 A.** No person, firm or corporation owning or occupying any real property within a residential zone of the Township shall permit any grass, weeds or any vegetation, not edible or planted for some useful or ornamental purpose, to grow or remain upon such premises so as to exceed six (6) inches in height or, Where weeds are concerned, to allow the same to go to seed. In all other zoning districts, the height shall be no more than 12 inches.

B. The following shall be excepted from the maximum height stated herein:

1. Areas within public or street rights-of-way that are maintained by Jackson Township or the Commonwealth of Pennsylvania, Department of Transportation.
2. Areas within or a part of stormwater facilities that are designed to operate with grass, weeds or vegetation in excess of the maximum height restrictions stated herein.

#### **93-2. Responsibility of occupants.**

Persons responsible for meeting the requirements of this chapter shall be the occupiers of the premises and/or the owner thereof.

- Low Volume Customers must attach a bag to a bulk item.
- Call Penn Waste to schedule collection of bulk items and appliances containing freon (air conditioners, refrigerators, freezers, etc.)
- No construction debris will be collected curbside.

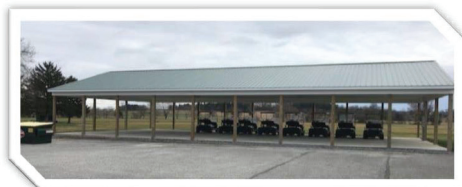

## WHY IS STORMWATER A PROBLEM?



In 2016, DEP labeled approximately 19,000 miles of rivers and streams in Pennsylvania impaired for water supply, aquatic life, recreation, or fish consumption. Stormwater runoff pollution is one of the biggest reasons for this impairment.

Over the past 100 years, streets, parking lots, sidewalks, and roofs have been a steadily increasing part of our communities as we've developed more and more of the landscape. As a result, rain that would otherwise soak into the ground instead rushes over these nonporous surfaces and into storm drains, which send it directly into rivers and streams.

Stormwater carries an enormous amount of pollution, including sediment, car oil, lawn fertilizers, pesticides, pet poop (and viruses and bacteria), and cigarette butts. As you might expect, this has many negative impacts on streams and rivers.

- Rivers are the source of our drinking water supply; when rivers aren't healthy, public health risks increase.
- Sediment harms aquatic life when it smothers macroinvertebrates and clogs spaces between rocks, destroying essential habitat for many species.
- Fertilizers stimulate excessive algae growth, causing algal blooms that remove oxygen from the water. Fish and other aquatic organisms can't exist in water with low dissolved oxygen levels.
- Bacteria and other pathogens can wash into swimming areas and create health hazards, making beach closures necessary.
- Debris—such as plastic bags, six-pack rings, and cigarette butts—washed into rivers can choke, suffocate, or disable ducks, fish, turtles, and birds.
- Household hazardous wastes like insecticides, pesticides, paint, solvents, and motor oil can poison aquatic life.
- Land animals and people can become sick or die from eating diseased fish and shellfish or ingesting polluted water.
- Because groundwater levels don't get fully replenished, springs and wells can go dry.



Project Lifesaver provides law enforcement with a program designed to protect, and when necessary, quickly locate individuals with cognitive disorders who are prone to the life threatening behavior of wandering. The necessity of this program was determined through the correlation between cognitive conditions and the act of wandering. The program has grown from a localized program to a program recognized internationally as a proven and effective method of “bringing loved ones home.”

The method relies on proven radio technology and specially trained search and rescue teams. Citizens enrolled in Project Lifesaver wear a small transmitter on the wrist or ankle that emits an individualized frequency signal. If an enrolled client goes missing, the caregiver notifies their local Project Lifesaver agency, and a trained emergency team responds to the wanderer’s area. The first responders will then use the client’s individualized frequency to locate the position of the individual.

The Northern York County Regional Police Department has nine officers trained in the operation of the Project Lifesaver Program. Four of these officers are School Resource Officers.
