## CALL TO ORDER:

## **APPROVAL OF MINUTES:**

- d. A motion was made to approve the Chapter 94 Report and authorize the Authority's Engineer, Colin Cash to submit it to DEP by McDonald/Hudgins, motion carries 3-0.

**OTHER BUSINESS:** There was none scheduled.

- A. Plant Superintendent's Report: There were no questions on the Plant Superintendent's Report.
- B. Engineer's Report: Colin reviewed his report for the Board. There were no questions.
- C. Solicitor's Report. None Scheduled

**D.** Administrator's Report. The Administrator was happy to announce that the LSA Grant that was submitted 13 months ago was awarded for the Interceptor Project. The Authority was awarded \$731,136.00. Our share towards the project will be \$129,024.00. Our funding will be broken down into \$81,000.00 of remaining Bond money and \$48,024 from the Capital Reserve fund. Flo thanked Colin Cash and CS Davidson for their work on this grant with her. We will begin putting the bid specs together for the project.

Flo also informed the Board that the Superintendent and the operators will be attending the Wastewater Conference in State College and that she will be filling in at the lab. Colby created a great guidebook and we should have no problems.
