A motion recommending approval of Section 107-18.C (1)(d) Basin Side Slopes to allow a 3:1 slope plus appropriate planting mix was made by King/Dunham, motion carried 3-0.

A motion recommending approval of Section 113-56.C (1) Sidewalks grass strip between the curb and sidewalk was made by King/Dunham, motion carried 3-0

c. Revised Kern Plan from Major to Minor Subdivision 5 Lot – Applicant: Michael and Janice Kern was pulled from the agenda by the Applicant.
