## JACKSON TOWNSHIP YORK COUNTY, PENNSYLVANIA

ORDINANCE NO. 226 - 2022

AN ORDINANCE OF THE TOWNSHIP OF JACKSON, YORK COUNTY, PENNSYLVANIA, AMENDING ITS CODE OF ORDINANCES BY REPEALING CHAPTER 50, ENTITLED "OPEN BURNING; OUTDOOR FIRES," IN ITS ENTIRETY AND REPLACING IT WITH A NEW CHAPTER 50, WITH THE SAME TITLE

**NOW, THEREFORE, BE IT SO ENACTED AND ORDAINED,** by the Board of Supervisors of Jackson Township, York County, Pennsylvania, by the authority of the same, as follows:

Section 1. Chapter 50, entitled "OPEN BURNING; OUTDOOR FIRES," of the Code of Ordinances of Jackson Township, York County, Pennsylvania, is hereby amended by deleting it in its entirety and adopting in its place as Chapter 50 of the Code of Ordinances of Jackson Township, York County, Pennsylvania, the attached document, with the same title.

## Section 2. Severability.

It is hereby declared to be the legislative intent that if a court of competent jurisdiction declares any provisions of this Ordinance to be invalid, the effect of such decision shall be limited to those provisions which are expressly stated in the decision to be invalid. In such case, all provisions of this Ordinance that were not declared invalid shall continue to be separately and fully effective. The Board of Supervisors hereby declares that it would have passed all other parts of this Ordinance, without including any part declared invalid, if it had advance knowledge that such part would be declared invalid. If the entire Ordinance should be declared invalid, then the Ordinance that was in effect immediately prior to the enactment of this Ordinance shall automatically be re-instated as the Open Burning Ordinance for Jackson Township.

## Section 3. Procedural Defects in Enactment.

Allegations that this Ordinance or any amendment was enacted in a procedurally defective manner shall be appealed as provided in Pennsylvania law.

## Section 4. Repealer.

The current version of Chapter 50, entitled "Open Burning; Outdoor Fires," is hereby repealed and all other Township ordinances or parts thereof that are inconsistent or incompatible herewith are repealed to the extent of such inconsistency or incompatibility. This Repealer clause shall only repeal Township ordinances or parts thereof that were

adopted prior to this Ordinance and that are clearly in direct conflict with this Ordinance.

Section 5. Enactment.

This Ordinance shall become effective in 5 calendar days, as provided by law.
